Spaniel Test: 9:15am start with Puppy followed by Novice. Open will be after lunch

Retriever Test: Puppy 9:15am start. Novice 10am start. Open will be after lunch

Entry Fee: Members £5, Non-Members £10

Membership application forms will be available

Entries on the field will require a completed entry form; entry forms will be available

Tests:

Puppy: Must be under 18 months on the date of the test

Novice: Confined to dogs that have not gained any award at a Field Trial or have been placed 1st in a Novice WGT or placed 1st, 2nd or 3rd in an Open WGT. Rule JGB(2)

Open: No restrictions

1st Place in Puppy, Novice and Open in the Spaniel and Retriever tests will receive a Gamebag

1st, 2nd & 3rd place will be awarded in each test; there will also be a trophy for the highest placed BASC member in each test.

BASC members please show membership card at time of entry.

All dogs must be KC registered and handlers would benefit from knowledge of the KC "J" Regulations. Judges will of course help and support newcomers
